Background:

The CALFED Bay-Delta Program is a cooperative effort among state and federal agencies and the public to ensure a healthy ecosystem, reliable water supplies, good quality water, and stable levees in California's Bay-Delta system. The Water Use Efficiency Program is one of several Program elements that the CALFED Bay-Delta Authority (the Authority) is implementing through an integrated approach. In its August 2000 CALFED Record of Decision, the Authority committed to initiate a public process to support the development of a definition of "appropriate measurement" as it relates to surface and groundwater usage. The Authority is convening an Urban Water Use Measurement Staff Work Group to assist the WUE Program Manager in developing a well-informed, implementable, and broadly supported definition.

Purpose of Meeting:

The April 7 meeting – the second of the full Work Group – will be directed toward: 1) further refining the scope and purpose of the Work Group; 2) discussing the relationship between Assembly Bill 306 and the Urban Water Use Measurement Staff Work Group; and 3) considering options to address particular concerns regarding the current state of urban water use measurement. Members of the public will be provided an opportunity to ask questions and provide comment. The Work Group's Meeting Agenda is provided below.
